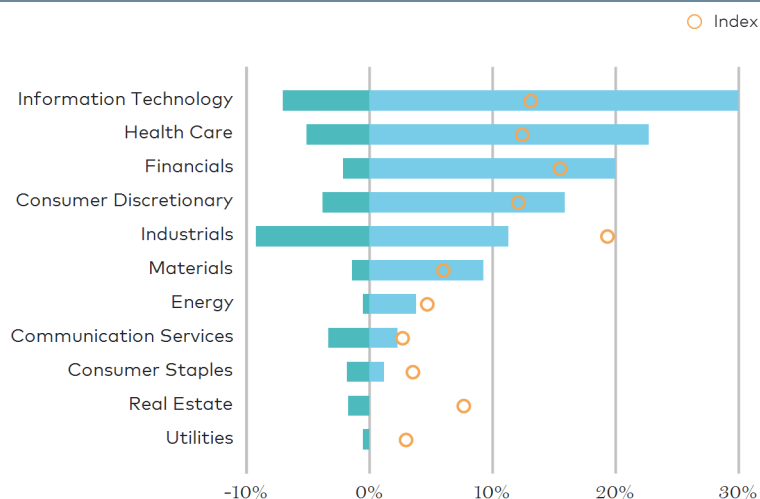

The greater the standard deviation, the greater a fund's volatility (risk). **Sharpe Ratio** is calculated using standard deviation and excess return to determine reward per unit of risk. The higher the Sharpe ratio, the better the fund's risk-adjusted performance.
