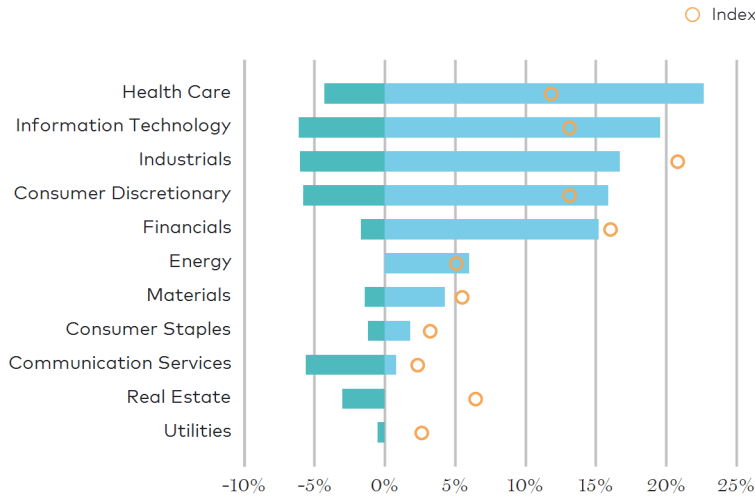

The higher the Sharpe ratio, the better the fund's risk-adjusted performance.
